ALUMNI AWARD DESCRIPTIONS

The BCM Alumni Association Awards Program recognizes alumni, faculty, and students of Baylor College of Medicine for excellence in achievement and service. Award categories and criteria are established by the Executive Committee of the BCM Alumni Association.

Definitions:

Alumnus: An alumnus is any individual who has successfully pursued an educational or training program at BCM.

Faculty: A faculty member is any individual who holds a current faculty appointment at BCM.

Distinguished Alumnus Award: The Distinguished Alumnus Award is presented to alumni who make outstanding contributions to biomedical and/or medical science through clinical service, research, education, and/or administrative leadership. Distinguished Alumnus Awards are presented in three categories: medical; graduate; and, allied health sciences. Up to two awards in each category may be presented annually.

Young Alumnus Award: The Young Alumnus Award is presented to alumni who make outstanding contributions to biomedical and/or medical science through clinical service, research, education, and/or administrative leadership and who, at the time the award will be presented, will not yet have reached their 46th birthday. Young Alumnus Awards are presented in three categories: medical; graduate; and, allied health sciences. One award in each category may be presented annually.

Distinguished Faculty Award: The Distinguished Faculty Award is presented to BCM faculty who make outstanding contributions through clinical service, research, education, and/or administrative leadership. Up to two awards may be presented annually.

Distinguished Service Award: The Distinguished Service Award is presented to alumni for outstanding service to BCM and/or the BCM Alumni Association. Up to two awards may be presented annually.

Humanitarian Award: The Humanitarian Award is presented to alumni for outstanding service to mankind including humanitarian, public and/or government service. Up to two awards may be presented annually.

Lifetime Achievement Award: The Lifetime Achievement Award is presented to alumni whose lifelong pursuits have achieved the zenith of accomplishment and serve as an inspiration to others. Up to two awards may be presented annually.

DISTINGUISHED ALUMNUS DESCRIPTIONS – GRADUATE SCHOOL OF BIOMEDICAL SCIENCES

Carolyn L. Smith, Ph.D., Fel. '94

Outstanding Alumni from the Graduate School of Biomedical Sciences will have used their scientific training obtained at BCM to launch a career that has led to substantial advances in scientific knowledge or application of knowledge to advance healthcare, biomedical research and/or education of the next generation of biomedical scientists. Scientific achievement as evidenced by publications (high impact science, top tier journals), invited lectureships, patent awards,

Leadership in science or science-related field: Academic leadership such as department chair, deans, institutes, CEO of biotech/start-up company, major leadership in pharmaceutical company, leadership of research consortiums

Leadership in Education: Deans, Provost, academic institution and their achievements in advancing education.

Major Service: Leadership of national academic/educational/professional societies, leadership of national effort to shape education and biomedical training

National Awards: Major named awards from professional societies, major research prizes, honorary degrees

DISTINGUISHED ALUMNUS DESCRIPTIONS – SCHOOL OF HEALTH PROFESSIONS

Physician Assistant Program – *Carl Emil Fasser, B.A., PA*

All attain national board certification and state licensure following graduation before taking positions in clinical practice, education, industry, or the uniformed services. They can be further differentiated by certificates of added qualification (CAQs) in emergency medicine, hospital medicine, Nephrology, Orthopedic surgery, cardiothoracic surgery, pediatrics and psychiatry. Some obtain added certification as diabetes educators and health educators. The newest certification possible through the ACLM is lifestyle medicine to be implemented in February 2017. These credentials apply mostly to those in the clinical setting.

Achievement in the academic setting is measured by advancement in faculty rank, the receipt of grant awards, scholarly publications, research, and achievement awards such as a Fulbright & Jaworski or the Barbara and Corbin Robertson Presidential Award. At the national level, it would be a Master Teacher Award or a Distinguished Service Faculty Award. Invited lectureships are another way in which to recognize the PA scholar.

Achievement as a scientist, such as Antone Opekun, also occurs in the academic setting but has markers that go beyond promotion and scholarship. For the few in this setting the markers are NIH and NSF funded awards, publications in the top science journals, novel ideas and patents, and the mentorship of junior faculty and graduate students.

Within industry the accolades come in a much different fashion. They involve appointment to key positions, a reputation as a thoughtful leader, and the receipt of distinguished awards given by the respective organizations.

There are two other markers that can be used to recognize the distinguished PA Alumna in any of these categories that include being selected as a Distinguished Fellow of the American Academy of Physician Assistants and the distinguished alum of the PA Program.

Other distinguishing markers include much of the elements Jim Walker indicated to include appointment to influential committees, nomination, and selection for key leadership positions, and serving in public office.

DISTINGUISHED ALUMNUS DESCRIPTIONS – SCHOOL OF HEALTH PROFESSIONS

Orthotics and Prosthetics Program – *Jared Howell, M.S., CPO, LPO, FAAOP*

I would imagine that the criteria are very similar to those identified by the Med School. To get the ball rolling, I would imagine my primary indicators would be:

- Scholarly Contribution
- National/International
- Reputation Educational
- Outreach/Commitment
- National/Professional
- Involvement

Criteria for these things can often be very subjective. These awards are often by recommendation or application based on the graduate's work or influence following graduation.

Nurse Anesthesia Program – *James R. Walker, DNP, CRNA, FNAP, FAAN*

I think about this from a professional impact perspective. There are a number of ways that an alum could have a distinguished (i.e., above average) impact. Things I believe would demonstrate impact are: 1) holding a faculty position with a reputable university, 2) awards from students/faculty/institutions, 3) publications, 4) recognized researcher, 5) professional organization leadership/awards/recognition (state, national, international), 6) service on influential committees leading to practice improvement/development/education/accreditation, 7) program development, 8) clinical leadership positions (e.g., chair, chief, director, etc.), 9) organizational leadership (e.g., president, vice president, chief nursing executive/officer, director positions, etc.), and 10) health policy involvement (e.g., committees, task forces, running for or serving in a public office in city/county/state/national governments). I'm sure there are other ways to demonstrate impact, but this is a start for the conversation the awards committee may have.
